

**Saskatchewan Mustard Development Commission (Sask Mustard) is accepting nominations to fill two positions on the board of directors.**

**Responsibilities include:**

- The board of directors' primary role is to direct the operation of Sask Mustard by developing overall objectives, policies, goals, and providing accountability to the members.
- Directors attend approximately five regular board meetings per year by Zoom and are sometimes called upon to represent the commission at meetings and major conferences that help shape the mustard industry.
- Directors serve a three-year term and are eligible to run for an additional two consecutive terms.

As per Sask Mustard's regulations a "registered producer" means a producer who:

- (i) is registered with the commission pursuant to section 20;
- (ii) has paid a levy pursuant to subsection 22(1) in at least one of the last three years for which he or she has not received a refund pursuant to section 23.

If you are a registered mustard producer and would like to be instrumental in growing Saskatchewan's mustard industry, please fill in the following documents and send to the returning officer (information below):

- Nomination Form (must be signed by 3 other registered producers)
- Candidate Bio and Headshot
